

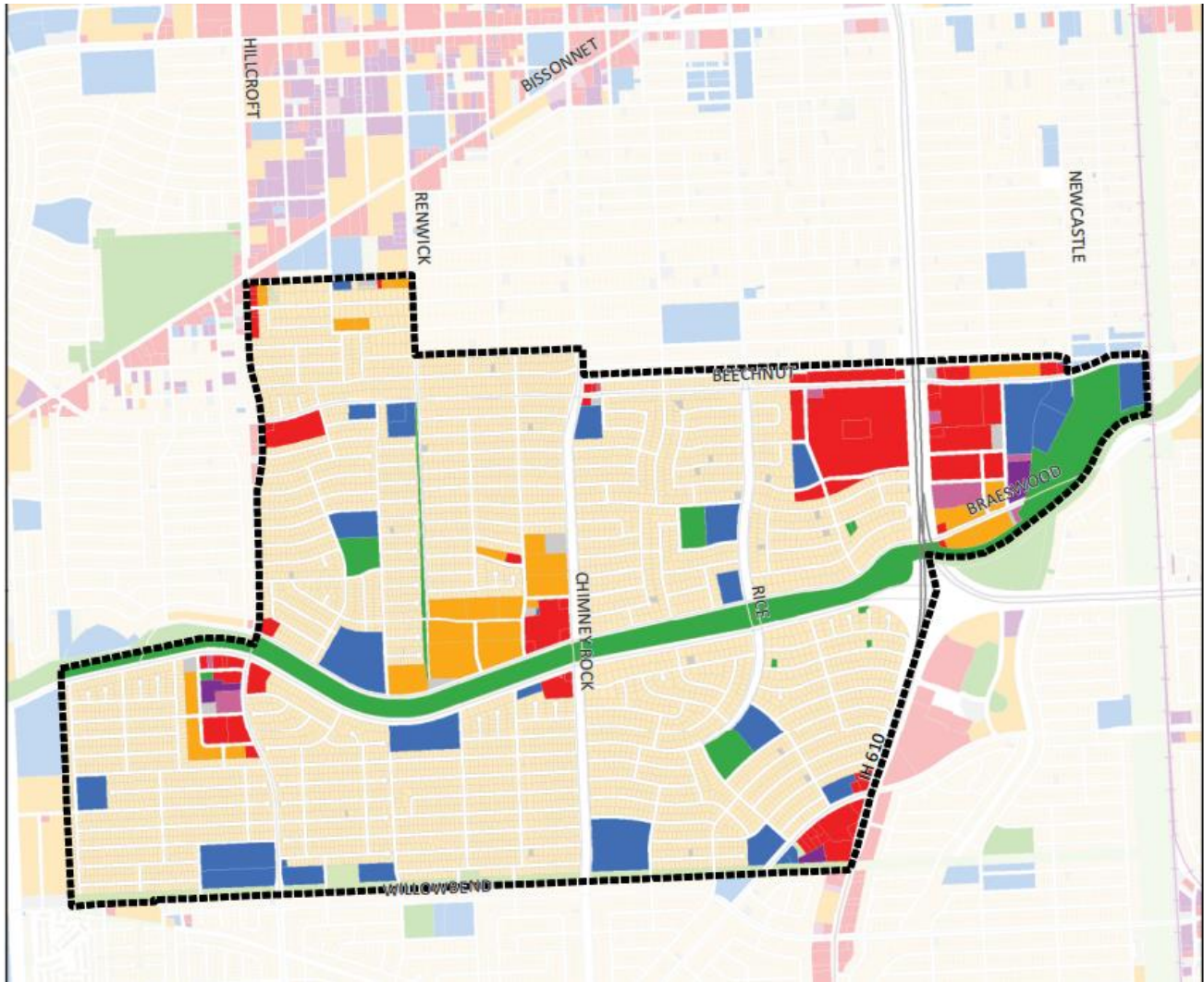
Super Neighborhood #31 Greater Meyerland



What is a Super Neighborhood?

A SN is a forum where residents and stakeholders can collaborate on neighborhood issues and work with city officials to be more responsive to community needs.

SN#31 Boundaries



Bob White south of Brays Bayou, Hillcroft north of Brays Bayou on the west; power easement along Willowbend on the south; I-610 to Brays Bayou, Brays Bayou to the railroad tracks on the east; city of Bellaire to the north.

In addition, the J represents 4,600 families.

What is the process?

As outlined by the City of Houston a group must take these steps:

1. Identify Stakeholders in the Community

Your community must demonstrate that stakeholders were given ample opportunity to participate and that no interested stakeholder was denied participation.

2. Create an Organizational Framework

Your council may choose to simply adopt "Articles of Incorporation" with the approval of all participating entities. In a more structured approach, stakeholders may agree to form a tax-exempt 501(c) (3) non-profit corporation or similar entity.

3. Adopt By-Laws

After agreeing on an organizational framework, stakeholders will formulate and adopt by-laws. By-laws address fundamental issues on conducting business and making decisions.

4. Become a Super Neighborhood

Once you have completed the steps to forming a council, your council will be officially recognized at a ceremony by the Mayor and city officials.



Why is this important to you?

Top Reasons to Become a SN

1. Recognition by City of Houston and a louder voice
2. Connect neighborhoods with common issues and interests so we can share knowledge and resources and work towards solutions (ex: flooding)
3. Stay up to date on city projects within SN boundaries
4. One on one with elected City officials at monthly meetings
5. Become a member of the larger group of Super Neighborhoods, the Super Neighborhood Alliance (SNA)
